2017 total of 866 represents <u>57%</u> of our retirees (1,525) and <u>45%</u> of available retirees (1,910), including surviving spouses (385) Active members 712 represent <u>47%</u> of retirees (1525)

Pension Landscape

- Continued movement from Defined Benefit Pension (FCA Canada Salaried DB Plan was frozen Jan 1, 2015)
- May 2017 Ontario Government announced proposed reforms to funding requirements.
- Dec 2017 Bill C177 was given royal assent effectively reducing solvency funding requirements.
- Feb 2018 Regulations proposed to reduce solvency funding from 100% to 85% and increasing PBGF from \$1,000 per month to \$1,500 per month.
- March 2018 Ontario Budget confirmation of their agenda

Funded status of SERP as of Jan 1, 2017


Going Concern (normal business and mkts.) 108% (108% prior yr est.)

New Developments

Federal

Federal Government Developments

- Sears bankruptcy brought attention to weak bankruptcy laws for pensioners
- Participated in CARP Day of Action February 21, 2018
- Continuing pressure on MP's and possible plank in Liberal policy platform.
- Arguments why pensions should not be fully funded are contrary to why pensioners should be given 'super-priority'. (Mike Powell's ACPM letter points)
- Our relationship with CARP participated in petition for Minister of Seniors

New Developments

Ontario

Ontario Government Developments

- New Framework for Defined Benefit Plans reduced solvency funding to 85% (understand rationale but need to protect what we were promised)
- Proposal to raise PBGF to \$1500/month still leaves many pensioners at risk at the next downturn – Ontario budget proposed retroactivity to May/2017 to help Sears pensioners
- Above changes ignored CFP's proposal to require plan sponsors to use 5% of \$1.4 billion in plan funding reductions to fully fund PBGF and protect all pensioners.
- Government has not met with us to discuss their rationale
 - Wynne promised a meeting with Sousa at Windsor Town Hall still no response
 - Ken Lewenza meeting to discuss CFP proposal was to get meeting with Finance Dept but to no avail.

Pension Benefit Guarantee Fund Sample Calculations

- PBGF only kicks in when there is a plan holder insolvency
- The PBGF cap of \$1,000 per month cap would be applicable prior to January 1, 2019
- The \$1,500 per month cap would be applicable January 1, 2019 and after, based on the proposed legislation changes. (retroactive to May 2017 to be applicable to Sears retirees)
- The sample calculations provided by FSCO provide greater clarity on how the PBGF benefit calculations would be applied
 - Only fully protects pensioners at or below the cap.
 - Those above will receive a benefit equal to the unfunded percentage times the PBGF cap, up to the PBGF cap.

Other Ontario Budget Highlights

- To look at 'Disclosable Events' as part of Pensions Benefits Act in response to Sears Sale of assets and special dividends with underfunded pension plan
- New FSRA Board to establish Committee to look at adequacy of PBGF after 3 years CCRetirees has taken lead on CFP committee to respond to this
- Distressed Pension Plan Workout Scheme included in above committee commitments
- Continuing discussion on conversion of defined pension benefits to targeted benefits for Multi-Employer Plans (if adopted, single employer plans would be next)

Election Planning

Election Planning

- Let your MPP know NOW you are not happy with your pension being put more at risk. Our Company is not our enemy – they will do what they are allowed to do.
- Letters, e-mails, phone calls are all effective. Copy to Wynne and/or Sousa OK
- CFP are developing prepared questions to be used when addressing a candidate – use them to find out where they stand (many candidates may know little about these issues but if their parties are hearing these questions often, they will know it is important to be addressed)
- CFP also developing each parties' position as it relates to this issue of solvency funding and pension security
